

NUS120 Charity Hongbao Walk

Terms and Conditions / Disclaimer

General

1. NUS120 Charity Hongbao Walk (the “**Event**” or “**Walk**”) is organised by the National University of Singapore, through the Office of University Communications, Development Office, Development Office and Office of Student Affairs (collectively known as “**NUS**” or the “**Organiser**”). These Terms and Conditions (“**T&Cs**”) apply to the Event.
2. By signing up for the Event, including but not limited to completion and submission of the online registration form, each individual (each a “**Participant**” and collectively “**Participants**”):
 - (a) acknowledges and agrees to abide by these terms and conditions; and
 - (b) where applicable, the Participant acknowledges and agrees on behalf of themselves and their child/ward (where applicable) to abide by these terms and conditions and any amendments that may be made from time to time.

The Participant agrees that the online registration for the Event is personal to the Participant and/or their child/ward and is not transferable to any other person, nor will any other person be permitted to participate in the Participant’s or their child/ward’s place.

3. Once registration is confirmed, a Participant and/or Participant’s child/ward is strictly NOT ALLOWED to:
 - (a) transfer his/her event entry to another party; or
 - (b) participate under another person’s name.
4. The Participant: (a) declares that they have provided true, accurate, current, and complete information about himself/herself and their child/ward (where applicable) in the online registration form (the “**Registration Data**”); and (b) agrees to maintain and promptly update the online Registration Data to ensure it stays true, accurate, current, and complete. The Organiser may contact the Participant from time to time by email and/or mobile contact number. Any notice sent to the email address and/or mobile contact number sent to the telephone number registered for the Event via the online registration form shall be deemed as received by the Participant.
5. If the Participant provides any information that is untrue, inaccurate, not current or incomplete or if the Organiser has grounds to suspect that such information is untrue, inaccurate, not current or incomplete, the Organiser may suspend or terminate the Participant’s or Participant’s child/ward’s registration.
6. Registration for the Event is only confirmed upon successful payment of the relevant registration fee and issuance of a confirmation email.
7. Upon successful registration for the Event, there shall be no refund of any registration fees and donation(s) to any Participant and/or Participant’s child/ward (where applicable) for any reason whatsoever including non-participation in the Event. It is the responsibility of the Participant to check that they have duly completed and submitted

the online registration form and to check that such registration has been accepted by the Organiser. The Organiser shall not be responsible for incomplete entry details or the failure to process and accept the Participant's and/or Participant's child/ward (where applicable) registration, including but not limited to any technical glitches, faults and/or delays that may occur.

8. The Organiser reserves the right to modify or substitute any of these T&Cs from time to time as they deem fit without any notice or liability to any party. If there is ambiguity in any of these provisions, NUS shall be the sole authority to interpret them. Any amendments to these T&Cs will be updated on the Official Website. All Participants understand and agree that by participating in the Event, they accept any change or update in these T&Cs, as updated by NUS from time to time.
9. NUS' decision on all matters relating to the Event is final and binding on all Participants. NUS will not entertain any queries about the entitlements, and will not be obliged to provide the reason(s) for its decisions to a Participant.
10. The Organiser reserves the right to cancel, postpone or modify any part of the Event or any component of it, including but not limited to the date, course and/or location, at any time without prior notice and without liability to the Participants. In the event of such cancellation, postponement or modification, the Organiser will post the details of cancellation, postponement, or modification on the Official Website, and the Organiser will make every effort to inform the Participants before the date of the Event. If the Event or any component of it is cancelled, postponed, or modified, there shall be no refund of registration fees and donation(s). The Organiser shall not be liable for any loss or inconvenience caused.
11. NUS shall not be liable for/or in respect of any expenses, losses, costs, damages, liabilities or other consequences of whatsoever nature (collectively "**Losses**") suffered or incurred directly or indirectly by Participants howsoever caused or arising and without NUS or its agents or employees are advised of the possibility of such Losses.
12. NUS reserves the right to:
 - (a) investigate cases of suspected fraud and suspend a Participant from the Event or clawback any entitlements already provided to the relevant Participant; and/or
 - (b) disqualify and withdraw the participation of any person who is non-compliant with the T&Cs of the Event, in NUS' sole and absolute discretion.
13. The terms and conditions of the Event shall be governed by and interpreted following Singapore law. The courts of Singapore shall have exclusive jurisdiction over any disputes arising from the terms and conditions, including the validity and enforceability thereto.

Personal Data

14. By registering for the Event, each Participant agrees and consents to NUS, as well as their respective representatives, agents and the authorised service providers and relevant third parties, collecting, using, disclosing, and/or sharing amongst themselves the Participant's and where applicable, their personal data, for purposes reasonably required by the Organiser to (i) administer and conduct the Event; (ii) to promote the Event including using any photographs, videos, motion pictures, images, recordings, or any other recording of the Event and its Participants for any commercial advertising and promotional purposes linked to the Event or future purpose or held by NUS, (iii) measuring the success of the Event; and (iv) obtaining feedback from participants on

the Event; and such other purposes for NUS, which each Participant confirms they have read and understood.

In addition, where a Participant discloses personal data of any person, that Participant further confirms and represents that they have obtained the consent of the individual concerned for the Purposes, unless such consent is not required under applicable laws: (i) to collect such personal data; (ii) for the disclosure of such personal data to NUS; and (iii) for the Organiser's collection, use and/or disclosure of such personal data.

15. (a) Each Participant on behalf of themselves, and their child/ward (where applicable), irrevocably grants perpetual, worldwide, compensation-free and unlimited permission for NUS to use, reproduce, disseminate and distribute any photographs, videos, motion pictures, images, recordings or any other form of record of the Participant and their child/ward's participation in the Event or related activity, whether in original or edited format, and whether now known or in the future invented, for any commercial advertising and promotional purposes (including promoting or advertising for the Event or NUS) ("**Promotional Purposes**"), across all media and platforms (including but not limited to print, radio, local television programs), or in any other format or media (including but not limited to electronic, social and digital media).
- (b) Each Participant acknowledges that such permission includes allowing NUS to use and reproduce the Participant/child/ward's name, email, nickname, image, likeness, voice, photograph, and biographical information for Promotional Purposes in connection with the Event or future editions of the Event or for NUS.
- (c) For the avoidance of doubt, the Participant and the Participant's child/ward will not be entitled to any compensation in connection with 16(a) and 16(b) herewith. In consideration and in return for being allowed to participate in the Event, the Participant releases and agrees not to take any legal action against NUS and its related partners from all present and future claims regarding the use of the Participant and the Participant's child/ward's photographs, motion pictures, images, recordings or any other form of record, by Participant and their heirs, assigns, spouses, partners, personal representatives and/or next of kin.

Health and Safety

16. The Participant declares as a condition of entry into the Event that (i) the Participant has undertaken appropriate and sufficient training for the Event; (ii) the Participant's child/ward has taken appropriate and sufficient training for the Event; (iii) the Participant is not aware of any condition, illness, injury, or disability for themselves or their child/ward that may cause or result in injury or death during or because of participating in the Event; and (iii) the Participant shall keep themselves informed, and shall be responsible for assessing the dangers, hazards, and other risks of taking part in the Event notwithstanding any actions or activities undertaken by the Organiser and its employees, directors, agents, or contractors in promoting, staging, organising, or marketing the Event.
17. Every Participant is responsible for themselves or their child/ward's involvement in the Event. NUS will not be liable for any injuries, mishaps, sickness, death or loss/damage to personal property that may occur during the Event. Every Participant needs to be aware that participation in the Event may be physically demanding and may involve a certain amount of risk and in choosing to participate, every Participant acknowledges that they accept all risks associated with participation in the Event and that such acceptance is a precondition to their participation. Every Participant understands that

they will have to cooperate fully with NUS and the Organiser and diligently comply with all safety instructions, directions and requirements, including any safe management measures and vaccination requirements related to COVID-19 as required by prevailing government guidelines.

18. Participants agree that in the event of any emergency, injury illness or detriment whatsoever, they hereby irrevocably authorise the Organiser and officials to transport themselves or their child/ward (as the case may be) to a medical facility and/ or to administer emergency medical treatment and the Participant waive all claims that might result from such transport and/or treatment or delay or deficiency therein. The Participant shall repay or reimburse any of the Organiser's medical and emergency expenses and the Participant hereby authorises the Organiser to incur the same. The Participant shall provide Event officials with such medical data relating to the Participant or child/ward as they may request. The Participant agrees that nothing herein shall oblige the Organiser or any other person to incur any expenses or to provide any transport or treatment.
19. Every Participant agrees to waive all claims of whatsoever nature against NUS, their respective subsidiaries and affiliates, and the officers, directors, employees, agents, representatives, successors, assignees, and insurers of such entities and any third party acting on its behalf or working within the framework of the Event (collectively, the "**Indemnified Persons**") and agree to indemnify and hold harmless the Indemnified Persons for any damage to or loss of property or any injury or loss of life which may be sustained by the Participant or their child/ward in the course of or arising from any cause in connection with (a) his/her participation in activities related to the Event; and (b) any claim made against the Indemnified Persons by a third party arising out of or in connection with any of the above.
20. Participants should not engage in any physical activity or Event activities if they are not feeling well.
21. The route will include several steep uphill sections and rough surfaces which may be challenging for some Participants.

Age Requirements

22. Any Participant below the age of 18 is required to seek parental/guardian consent when registering, failing which the Organiser reserves the right to refuse registration to that Participant. For the avoidance of doubt, the Participant's age will be determined as of 1 November 2024.
23. Participants below the age of 18 years of age shall seek parental or guardian's consent before registering and participating in the Event. In such an instance, the Participant's parent or guardian certifies that they have read this document, fully understand, and agree to these terms and conditions for and on behalf of the Participant or their child/ward.
24. The minimum age for participation in the Event is 12 years old.
25. Participants may be accompanied by their children/wards/dependents who are below the participation age. In such cases, Participants shall be solely responsible for the safety of their children/wards/dependents, and the Organiser shall not be liable for any resulting losses or injuries sustained in connection with their participation in the Event. Such children/wards/dependents shall not be considered as Participants, and will not enjoy or entitlements and/or privileges accorded to the Participants.

Entitlements

26. T-shirt sizes are subject to availability.
27. There is no medal to be issued on the day of the Event at the Finishing Area at University Hall, upon completion of the Walk. This is a non-competitive Event.

Event

28. The Event will be held on Saturday, 8 February 2025, from 7.30am to 11.30am at University Hall, 21 Lower Kent Ridge Road, Singapore 119077.
29. The Organiser reserves the right to amend the Walk routes as they deem fit for the safety of the Participants and/or to prevent any potential hazards in the running of the Event, at any time without prior notice to the Participants. In such cases, every effort will be made to inform the Participants before the date of the Event. The Organiser shall not be liable for any other loss or inconvenience caused due to such changes.
30. Participants must wear their Event T-shirt at all times during the Walk. Participants without the allocated T-shirt will not be allowed to take part in the Walk.
31. The Organiser reserves the right to delay the commencement of the Walk in the event of inclement weather. Should inclement weather persist after the delay, the Organiser reserves the right to cancel the Event without refund of donation or registration fees.
32. Participants who do not start within 30 minutes from their respective flag-off point, should consider removing themselves from the Walk and for safety reasons, will not be allowed to start. The cut-off timing for the 8km Walk is 2.0 hours.
33. No pets, or any form of wheel-run objects of transport e.g. inline skates, or shoes with built-in or attached rollers are allowed on the course during the Walk except for baby prams, push cars, official Events and medical vehicles.
34. For safety reasons, expectant mothers will only be allowed to participate in the Event if they can provide a medical certificate from a qualified gynaecologist in Singapore certifying that she is fit to participate in the Walk. The certificate should be dated within seven days of the Walk.
35. Baggage deposit services are not provided on the Event day. The Organiser will not be held responsible for any loss and/or damage, personal or otherwise, to the belongings and items deposited. Please travel light!
