

After confirmation and payment, you will be allocated a booth space on one (1) of the event days.

## **Event & Registration**

- 1. Upon receipt of the company's or employer's (also referred to herein as "Participant" or "you" or "your") registration to participate in the NUS Career Fest 2025 ("Event") and by you registering for the Event, you accept these terms and conditions ("Terms") and agree to abide by them.
- 2. The National University of Singapore (NUS) acting through its Centre for Future-ready Graduates (CFG) will notify you on the outcome of your registration latest by end December 2024.
- 3. CFG reserves the right to decline any registration submitted. Your participation in NUS Career Fest 2025 is confirmed only upon acceptance of your registration by NUS and completion of payment by you.
- 4. CFG reserves the right to
  - a) modify these Terms at any time by posting the changes on the Event website;
  - b) make changes to the Event details (i.e. Event Date / Time / Venue);
  - c) decline any registrations submitted at its discretion;
  - d) restrict access to or remove any Participant's content or material if the content or material is found to be in violation of the Terms, or
  - e) disqualify or terminate any Participants who are found to have violated these Terms.

## **Employer Participants**

- 5. The employer participation fee is SGD1,300. This fee is subject to 9% GST or the prevailing rate.
- 6. Payment of the participation fee must be received through the Payment Link provided in your offer email, by the specified due date. Participant can make payment via VISA, MasterCard, Amex, Alipay or PayNow. Upon receiving Participant's successful registration and payment, CFG will send a Confirmation Email to the Participant to confirm your participation in the NUS Career Fest 2025. Payment made is non-refundable.
- 7. CFG will collect data provided for billing and publicity purposes related to NUS Career Fest 2025 and by registering for the Event, you consent to the use of data for such purposes.

## **Participant's Conduct**

8. A maximum of four (4) company representatives per organisation are allowed at the physical fair Event venue at any given time.

## **Confidentiality**

9. Participants ("Recipient") receiving confidential information (including personal data) shall not at any time disclose to any person confidential information of the disclosing Participant ("Discloser), except as permitted by the Discloser. The Recipient shall only use the Discloser's confidential information for the sole purpose of participating or performing its obligations for the Event. The Recipient may only disclose confidential information to its employees or officers who need to know such information, or if required by law, to a court of competent jurisdiction or any governmental or regulatory authority. Each party shall ensure that the persons to whom it discloses the Discloser's confidential information comply with the confidentiality obligations.





10. Participants agree to co-operate with any reasonable requests by CFG relating to any promotional and publicity activities in connection with the Event.

### **Data Protection**

- 11. Participants consent to the collection, use and disclosure of any information provided, including, without limitation, information that may be deemed personal data under the Personal Data Protection Act 2012. NUS may retain your personal data and information (including business information) for as long as it is necessary to fulfil the purposes for which it was collected, or as required or permitted by applicable laws.
- 12. Personal data provided by the Participants may be used by NUS for the purposes of the Event and communicating with the Participants as well as for any future promotional, marketing and/or publicity purposes. By registering and participating in the Event, you are deemed to have given your consent to the processing of your personal data by NUS and/or its service providers in connection with the Event. You acknowledge and agree to NUS' Privacy Notice (https://ormc.nus.edu.sg/personal-data- protection/policies) and its legal information and notices (https://nus.edu.sg/legal-information-notices).
- 13. Participants acknowledge and agree that CFG may film, photograph and/ or make any other forms of recording of the Participants in connection with the Event ("Recording"); and intellectual property rights, title and interest in the Recording shall vest in NUS.
- 14. Participants shall comply with applicable data protection laws including the Singapore Personal Data Protection Act 2012 with regard to all personal data that it receives by participating in the Event. Participants agree that when dealing with personal data received either directly or indirectly in connection with the Event, Participant shall:
  - i. only use personal data in accordance with the purposes for which the personal data was disclosed;
  - ii. use best efforts to protect personal data against accidental or unlawful destruction or accidental loss, alteration, unauthorised disclosure or access and against all other unlawful forms of processing;
  - ii. give NUS notice in writing as soon as reasonably practicable should it be aware of, or reasonably suspect, that any of the events referred to in sub-clause 14(ii) above has occurred and shall use best efforts and render its full co-operation to NUS in remedying the incident and preventing its re-occurrence;
  - iv. do not retain personal data for any longer than is necessary for the purposes for which the personal data was disclosed;
  - v. limit disclosure of such personal data to persons on a need-to- know basis and only for the purposes of processing for which such personal data was disclosed; and
  - vi. not to disclose or transfer any personal data received to any third party (whether situated in Singapore or otherwise) without the express consent of that individual who may be identified by the personal data.

- 15. The copyright in the contents and materials made available by NUS are owned by NUS unless otherwise indicated as owned by third parties. NUS' logos, crests and name are trademarks or registered trademarks of NUS. NUS has policies governing the use of its name, including the names of its schools and programs, and trademarks and use, reproduction, copying or redistribution of the same without NUS' prior written permission is prohibited.
- 16. Participants represents and warrants that you own the content uploaded or posted by you and you have obtained the right to upload or post the same, and the posting of the content does not violate the intellectual property or other rights of any person. Third Party Data, Materials or Services.
- 17. Any third party data, materials or services (including payment systems, software, applications, URLs, links to third party websites) if any, hosted or made available by CFG are permitted or licensed by the respective third party licensors or service providers retain all ownership and intellectual property rights in the third party data, materials or services. Participants undertake to be responsible for complying with the separate third party licence or agreement terms and conditions (including any liability and indemnity requirements) specified or required by the respective third party licensors or service providers that govern Participant's use of any third party data, materials or services. Participants may locate such separate licence or terms and conditions that apply to the use of third party data, materials or services through readme or notice files of the third party licensors through links provided (if any), or if not available, then directly through the respective third party licensors' own websites. To the extent permitted by law, NUS disclaims all warranties or conditions of any kind, whether express or implied, including but not limited to the implied warranties of merchantability, fitness for a particular purpose and non-infringement. NUS does not review any third party websites and is not responsible for any content from any such websites.

Participants accept that the third party data and materials made available or otherwise drawn from third party websites may vary in standards and quality and the use of third party data and materials is therefore entirely at your own risk and discretion, and subject to your own due diligence.

NUS does not warrant that the Event or any data or materials made available to you will meet your requirements or that any system or platform or services will be available at all times uninterrupted, secure, accurate or error free.

NUS does not control Internet transmission and provides no warranty over security of any information transmitted over the Internet. Any data transmitted by you through the Event participation is transmitted at your own risk.





19. To the extent permitted by law, NUS excludes all liability for any direct or indirect, consequential or incidental or special loss of any kind (including loss of profits or revenue, or loss of or damage to any data), whether arising from breach of contract, tort (including defamation, infringement of intellectual property rights) or otherwise arising out of or in connection with the Event, whether or not notified of such damages or loss arising.

NUS shall not be liable for any loss, damage or penalty resulting from any failures in performance of any obligations under these terms and conditions as a result of events beyond the reasonable control of NUS. You undertake to indemnify and hold harmless NUS at all times against all actions, proceedings, costs, claims, demands, liabilities and expenses whatsoever (including legal and other fees and disbursements) sustained or incurred by NUS directly or indirectly in connection with, your participation in the Event (including any third party data, materials or services therein), or any materials, derivative works produced by you, or any breach by you of these Terms.

NUS accepts no liability for any claims, penalties, losses, or expenses arising from the use of, or reliance on any content; use of or inability to use the platform or site; or unauthorised access or alteration to the site. NUS will not be liable for any acts or omissions by you, including any damages of any kind incurred as a result of such acts or omissions.

20. These Terms are governed by and construed in accordance with the laws of Singapore. Any dispute arising out of or in connection with the Event or the Terms or agreement, including any question regarding its existence, validity or termination shall be referred to and finally resolved by arbitration administered by the Singapore International Arbitration Centre (the SIAC) in accordance with the Arbitration Rules of the SIAC (the SIAC Rules) for the time being in force, which rules are deemed to be incorporated by reference in this Clause. The seat of the arbitration shall be Singapore. The tribunal shall consist of one (1) arbitrator. The language of the arbitration shall be English.

# Frequently Asked Questions (FAQs)



### **General:**

- When is the NUS Career Fest 2025 happening?
   The event is happening on 18, 19, and 20 February 2025, from 10am to 5pm in a physical format.
- At which part of University Town will the employer booths be located?
   Employer booths will be located at the Stephen Riady Centre, a central location in University Town. The booths will be in air-conditioned spaces.
- 3. Who is the target audience for NUS Career Fest 2025?

  NUS Career Fest 2025 will be publicised to our 30,000+ undergraduates, 10,000+ postgraduates, young NUS alumni, and mid-career job seekers.
- **4.** How many students are expected to attend NUS Career Fest 2025? Career Fest 2024 was attended by more than 9,000 students over 3 days.
- 5. The NUS Career Fest will take place over 3 days, does this mean I get to attend the event on all 3 days? Each employer will only be participating for one (1) day and will be informed of the allocated day upon confirmation and payment.

## **Registration:**

- 6. How do I register for the event?

  Registration opens on Thursday, 28 November 2024 and will close on Wednesday, 11 December 2024.
- 7. I did not receive my registration acknowledgement email, could you resend it to me?

#### What is next after I have registered?

- **8.** You will be notified of the outcome of your registration and payment details via an Offer Email by end December 2024 after registration. Payment of the participation fee must be received by the specified due date in the Offer Email.
- 9. What are the payment methods available?
  You can make payment via VISA Mastercard Amey Alipay or PayNow
- 10. I have not paid. How do I complete my payment?

If your participation is confirmed by the Committee, you can complete your payment by logging in to your GevMe registration wallet link. This link will be sent to you separately at a later date. Kindly login with your registered email address and click on "Forget Password" to trigger an activation email. You can contact the NUS Career Fest Organising Committee at hire@nus.edu.sg for assistance.

11. I did not receive the participation confirmation email, could you resend it to me?

### **Career Fair:**

#### 12. What do we need to bring for the NUS Career Fest 2025?

You may bring one (1) pull-up banner (not more than 1m width), brochures and a thumb drive (with visual collaterals and job listings) to display on the TV. If you wish to use a laptop to display your media, please bring along a HDMI cable to connect the laptop to the TV. We urge exhibitors to check and ensure that any thumb drives and laptops to be used are compatible with the TV provided (for instance, video files are in MP4 format and thumb drives not encrypted).

#### 13. Can we build structures within our networking space?

No, you are not allowed to build any structures within the booth space.

#### 14. Will there be storage provided?

Due to space constraints, participating organisations are strongly encouraged to store their items within their booth space.

### 15. What if we require extra furniture (TV, chairs etc.) and customization for our networking space?

Due to space constraints, we are not able to cater to additional requests for extra furniture or setup.

#### 16. Can we distribute flyers and brochures to students?

Flyers and brochures are allowed within the allocated booth space. Delivering and receiving of promotional items and setup can only be done on the allocated fair days. The Organising Committee will not be responsible for receiving the promotional items on behalf of the employers. All leftover materials are to be removed by 5pm after the event.

#### 17. Can we withdraw from the event?

Once payment has been completed, withdrawal from the event is not allowed and payment is non-refundable.

### 18. Is there a maximum number of representatives allowed at the event?

A maximum of four (4) representatives are allowed to be present at the booth space at all times.

#### 19. Will lunch be provided?

Yes, four (4) meal coupons will be provided per organization.

#### 20 Can we consume meals outside of the stipulated lunch time?

Lunch will only be served within the stipulated lunch time at designated lunch areas. You may visit other food outlets within University Town. Do ensure that there must be at least one (1) company representative always stationed in the networking space during the entire event.

#### 21 Can we bring food from elsewhere for consumption in the event halls?

No food is allowed in the event halls

#### 22. Can we purchase additional parking coupons?

Due to limited parking lots available in University Town, we are unable to sell additional parking coupons. More information on parking directions will be provided at a later date.
