4	<b>Academic Content</b>	<p>The academic program consists of two courses which are taught consecutively over the duration of three weeks. Students are required to complete both courses. Completion is worth 8 ECTS credits. 5	<b>Eligibility Requirements</b>	<p>NUS' generic eligibility requirements apply, please see <a href="#">GRO website</a> for details. Applications and selections are subject to review by the host university.</p> <p>Host university's requirements are as follows:</p> <ul style="list-style-type: none"> <li>• Current enrolment in an undergraduate study programme in business administration or related fields (Economics is considered)</li> <li>• A minimum of one year of undergraduate education with a specific focus on business administration and related areas completed by the time of participation in the summer programme</li> <li>• An excellent command of English language. The English language requirements can be found <a href="#">here</a>.</li> </ul> <p>Applicants should also note that certain courses may have prerequisites.</p>

6	<b>Accommodation</b>	<p>To give students flexibility of choice, students are asked to book accommodation for the ISU<sup>WU</sup> on their own. 7	<b>Application Procedure</b>	<p>Apply to NUS via <a href="#">EduRec</a> and to WU via <a href="#">WU's website</a> concurrently. When applying to WU, you should apply as a “non-exchange student”.</p> <p>Please note that in addition to your direct application to WU, WU requires NUS to submit a list of applicants with personal details to them. As such, NUS Global will collect your Date of Birth information via EduRec and share it with WU.</p> <p>You <b>must</b> accept both the EduRec offer and the host university offer to confirm your participation in this programme.</p> <p>Only upon acceptance of the EduRec offer can you proceed with course mapping and application for financial aids.</p> <p>Applying on EduRec will allow NUS Global to contact and assist you in times of crisis/emergency while you are overseas. With an official application through EduRec, you will also be able to request NUS Global for supporting letters for visa application and NS deferment (for NSmen).</p> <p>Please read the <a href="#">EduRec application guide</a> before applying for the programme with NUS.</p>
8	<b>Course Mapping</b>	<p>Students interested in transferring units can start the course mapping process after applying and accepting the offer for the programme in EduRec. Course mapping request is subjected to approval from the Faculties. Click <a href="#">here</a> for a step-by-step guide on applying for course mapping.</p> <p>Please also note the following:          Students may map up to a maximum of 10 units for each Summer Programme and up to a maximum of 5 units for each Winter Programme. Course mapping will be subject to approval from the respective Faculties/Schools.</p> <p>A total of 12 units from a maximum of 2 overseas summer/winter and research programmes can be mapped without having to pay NUS tuition. Additional units mapped will be subjected to Special Term fees. For details, visit the <a href="#">Office of the University Registrar's website</a>.</p>
9	<b>Transcript</b>	<p>Please provide a valid, <b>personal</b> mailing address to the host university so that the host can send your transcript to you directly after the programme. If the host issues an electronic transcript, please provide your <b>personal NUS email address</b> to receive the transcript.</p>

10	<b>Visa Application</b>	<p>Students which are nationals of EU member states, the European Economic Area (EEA) and Switzerland do not require a visa in order to enter Austria.</p> <p>Nationals of countries which signed bilateral or multilateral agreements on the abolition of visa requirement, are visa-free if they stay in Austria for a maximum period of 90 days and do not take up employment. The website of the <a href="#">Federal Ministry for Europe, Integration, and Foreign Affairs</a> lists the visa-free countries.</p> <p>If you require NUS Global to issue a supporting letter for your visa application, NS deferment or OSP loan application, you may submit your request via this <a href="#">form</a> after you have applied in EduRec and received confirmation of acceptance from the host university.</p>
11	<b>Travel Advisories</b>	Visit the <a href="#">MFA website</a> for travel advisories on various countries from the Singapore government.
12	<b>Student Insurance</b>	<p><a href="#">NUS Student Travel Insurance</a> is provided for your participation in this programme.
