1	Programme Fee	<p>€3,000 for the 4-week summer school or €2,000 for the 2-week Austrian Arbitration Academy.</p> <p>The programme fee includes registration, tuition, use of all sports and recreational facilities (including windsurfing lessons), all planned excursions. More details can be found <a href="#">here</a>.</p> <p>A limited number of partial scholarships ranging from € 1,000 to € 3,000 are available for the European Studies section of the univie summer school. The scholarships are awarded on the basis of academic excellence and financial need. In order to receive a scholarship, students must demonstrate their financial need by describing their financial situation and submitting related documents.</p> <p>The application deadline for scholarship applications is <b>28 February 2026</b>. <b>PROGRAMME DETAILS</b>		
4	<b>Academic Content</b>	<p>The univie summer school lasts for four weeks and consists of two two-week sessions.</p> <p>12 European Studies courses, the Arbitration Academy course, and German Languages courses on four levels are offered:</p> <ul style="list-style-type: none"> <li>• European Studies courses last two weeks (4 ECTS each)</li> <li>• The Austrian Arbitration Academy course lasts two weeks (8 ECTS)</li> <li>• German language courses last four weeks (6 ECTS each)</li> </ul> <p>In the course of the four-week programme, <b>students are required to attend courses amounting to 10 ECTS credits</b>, with the exception that the Austrian Arbitration Academy can be attended as an independent programme.</p> <p>In order to meet this requirement, one of the following options is possible:</p> <ol style="list-style-type: none"> <li>1. Three European Studies courses, or</li> <li>2. The Austrian Arbitration Academy course plus one European Studies course, or</li> <li>3. One German course plus one European Studies course</li> </ol> <p>Students may also enrol in or audit additional courses. The maximum number of courses students may attend during the summer programme is four. (This includes German courses and/or courses taken for audit.)</p> <p>Please refer to the <a href="#">academic programme website</a> and the <a href="#">programme brochure</a> for more details.</p>
5	<b>Eligibility Requirements</b>	<p>NUS' generic eligibility requirements apply, please see <a href="#">GRO website</a> for details. Applications and selections are subject to review by the host university.</p> <p>Host university's requirements are as follows:</p> <ul style="list-style-type: none"> <li>• At least 18 years old</li> <li>• Have completed two years of studies at NUS</li> <li>• In attendance for the whole period of the univie summer school</li> <li>• Take part in the required number of courses</li> <li>• Have an adequate command of the English language</li> </ul> <p>Applicants should also note that certain courses may have prerequisites.</p>

6	<b>Accommodation</b>	<p>univie has on-campus housing for summer school participants. If the number of students exceeds the number of beds available on-campus, univie reserves the right to accommodate students in adequate double rooms off-campus nearby.</p> <p>For more information, please refer to:  <a href="https://shs.univie.ac.at/summer-school/orientation/accommodation-meals/">https://shs.univie.ac.at/summer-school/orientation/accommodation-meals/</a>.</p> <p>Should university-arranged accommodation not be available, you will be responsible for securing your accommodation.</p>
7	<b>Application Procedure</b>	<p>Apply to NUS via <a href="#">EduRec</a> and to <a href="#">univie</a> via email concurrently.</p> <p>The univie summer school has a rolling admission policy and considers applications in the order of their arrival. Since the univie summer school is unable to accept more than 100 students per year, early application is encouraged.</p> <p>You <b>must</b> accept both the EduRec offer and the host university offer to confirm your participation in this programme.</p> <p>Only upon acceptance of the EduRec offer can you proceed with course mapping and application for financial aids.</p> <p>Applying on EduRec will allow NUS Global to contact and assist you in times of crisis/emergency while you are overseas. With an official application through EduRec, you will also be able to request NUS Global for supporting letters for visa application and NS deferment (for NSmen).</p> <p>Please read the <a href="#">EduRec application guide</a> before applying for the programme with NUS.</p>
8	<b>Course Mapping</b>	<p>Students interested in transferring units can start the course mapping process after applying and accepting the offer for the programme in EduRec. Course mapping request is subjected to approval from the Faculties. Click <a href="#">here</a> for a step-by-step guide on applying for course mapping.</p> <p>Please also note the following:  Students may map up to a maximum of 10 units for each Summer Programme and up to a maximum of 5 units for each Winter Programme. Course mapping will be subject to approval from the respective Faculties/Schools.</p> <p>A total of 12 units from a maximum of 2 overseas summer/winter and research programmes can be mapped without having to pay NUS tuition. Additional units mapped will be subjected to Special Term fees. For details, visit the <a href="#">Office of the University Registrar's website</a>.</p>
9	<b>Transcript</b>	<p>Please provide a valid, <b>personal</b> mailing address to the host university so that the host can send your transcript to you directly after the programme. If the host issues an electronic transcript, please provide your <b>personal NUS email address</b> to receive the transcript.</p>

		Please do not request your transcript to be sent to NUS Global, and NUS Global is not responsible for missing transcripts.

10	<b>Visa Application</b>	<p>Students which are nationals of EU member states, the European Economic Area (EEA) and Switzerland do not require a visa in order to enter Austria.</p> <p>Nationals of countries which signed bilateral or multilateral agreements on the abolition of visa requirement, are visa-free if they stay in Austria for a maximum period of 90 days and do not take up employment. The website of the <a href="#">Federal Ministry for Europe, Integration, and Foreign Affairs</a> lists the visa-free countries.</p> <p>Please also refer to the <a href="#">host university's website</a> for more information.</p> <p>If you require NUS Global to issue a supporting letter for your visa application, NS deferment or OSP loan application, you may submit your request via this <a href="#">form</a> after you have applied in EduRec and received confirmation of acceptance from the host university.</p>
