7	Application Procedure at NUS	<p>Please apply through the NUS Education Records System - Global Education (EduRec-GE) first if you want to do module mapping and apply for financial aid/loans. Applying through EduRec-GE will allow GRO to contact and assist you in times of crisis/emergency while overseas.</p> <p>With an official application through EduRec-GE, you are covered by the NUS Travel Blanket Insurance. Besides, GRO can also provide you with supporting letters for visa application. Read the step-by-step guide we prepared for you on GRO's website.</p> <p>You should also concurrently apply to the host university once you have applied to NUS Edu-Rec.</p>
8	Application Procedure at Host University	<p>Please fill out our online application form. If you are applying for one of the business programmes, please support your application with the latest transcripts for your study programme (in English), proof of your English language level (only for non-native speakers and those not completing their degree in English) and a photograph of yourself. For the Entrepreneurship and Innovation Management Course, a letter of motivation is required, which answers the question: Why are you interested in entrepreneurship/innovation?</p> <ol style="list-style-type: none"> 1. Fill out the online form with your basic personal and academic information. You will receive a link to the online platform. Please create your own user account and password.

		<p>2. Upload all the necessary documents and complete your personal and academic information, using the user account you just created in Step 1.</p> <p>After submitting application, you will receive an email to inform you that your application has been received and whether or not it is complete.</p> <p>Once your application is complete and has been reviewed by our selection committee you will receive a short e-mail confirming whether you have been accepted (your acceptance is, however, still subject to the payment of the programme fees on time). Attached to this email you will find an invoice which needs to be paid within the timeframe stipulated in the email. Your application will be confirmed upon receipt of payment. You will then receive an official acceptance letter from us via email.</p>
9	Confirmation of participation	To confirm your participation in this Programme, you must accept both the EduRec offer and the host university's offer to confirm your participation in this programme.
10	Course Mapping	<p>All course mapping requests are subject to approval by the faculties/departments.</p> <p>If you are interested in obtaining credits for your course, you can start the course mapping process via EduRec-GE after you have accepted the programme offer.</p> <p>Students may map up to a maximum of 10 units for each Summer Programme. Over the course of study in NUS, students may map up to a total of 12 units for involvement in the summer programme. Beyond 12 units, NUS Special Term tuition fees will apply, in addition to Summer/Winter Programme fees paid to the host university. Please read the information on the Office of the University Registrar's website for details.</p>
11	Transcript	<p>Please provide a valid, personal mailing address in the online registration portal so the host can send your transcript to you after the summer programme.</p> <p>Please do not request that your transcript be mailed to the NUS Global Relations Office (GRO). GRO is not responsible for missing transcripts.</p>

12	Visa Application	<p>Holders of a Singapore passport do not require a visa for visits to Germany lasting up to 90 days. For other nationalities, please enquire with the Embassy of the Federal Republic of Germany in Singapore for visa requirements.</p> <p>If you need a visa to enter Germany, please start early as your visa application may take up to 2 months.</p>
