7	<b>Application Procedure</b>	<p>Apply via the <a href="#">host university's website</a>. <b>Your status when applying to the host university (University of Copenhagen) is "Non-EU/EEA without permanent Danish residence permit"</b>.</p> <p>Thereafter, inform GRO via email (<a href="mailto:orion@nus.edu.sg">orion@nus.edu.sg</a>) about the course(s) you applied for. You will then be provided instructions on applying via <a href="#">EduRec</a> (a critical step for your module mapping and financial aid applications). You must accept both the EduRec offer as well as the host university offer to confirm your participation in this programme.</p>
8	<b>Module Mapping</b>	<p>If you are interested in obtaining credit, you can start the module mapping process after you apply in EduRec and accept the offer for the programme. Note that all mapping requests are subjected to approval by the Faculties. <a href="#">Click here</a> for information on applying for module mapping. Please also note the following:</p> <ul style="list-style-type: none"> <li>• Students may map up to a maximum of 10 MCs for each summer programme and up to a maximum of 5 MCs for each winter programme. Module mapping will be subject to approval from the respective Faculties/Schools.</li> <li>• Of the MCs approved for mapping, a total of 12 MCs from a maximum of 2 overseas summer/winter and research programmes can be mapped without having to pay NUS tuition. Additional MCs mapped will be subjected to NUS Special Term fees.
