Due to the COVID-19 situation, Keio has announced that they are offering the Keio Summer Program online, which gives you the opportunity to experience Japan’s higher education system from anywhere in the world. Keio will use online lectures, group seminars to make summer classes as engaging and informative as possible.

Students may apply for module mapping and transfer a maximum of eight (8) MCs (this is applicable only to electronic summer programmes 2021). Please note that some Schools or Faculties (including School of Computing) will not approve module mapping for remote or online courses. Please check with your home School or Faculty Dean’s Office to determine if module mapping can be approved for remote/ online courses before applying to the partner university.

6	Module Mapping	<p>If you are interested in obtaining credit, you can start the module mapping process after you apply in EduRec and accept the offer for the programme. Note that all mapping requests are subjected to approval by the Faculties. Click here for a step-by-step guide on applying for module mapping.</p> <p>Students may map up to a maximum of 10 MCs for each Summer Programme. Over the course of study in NUS, students may map up to a total of 12 MCs for summer programmes. Beyond 12MCs, NUS Special Term tuition fees will apply, in addition to Summer/Winter Programme fees paid to the host university. For details, visit the Registrar's Office website.</p>
