Conditions

 fines not paid or any other liability that might be incurred are settled.
- Each application will be charged a non-refundable registration fee of \$32.70 (inclusive of GST).
- Membership fees are not refundable.
- There will be a charge of \$10.90 for any change of membership card.
- All fees and charges payable by the applicant are inclusive of 9% Goods and Services Tax (GST).

Loan Entitlement and Membership Fee

Companies / Organizations may apply for **one corporate card.** The card will bear the name of the organization and is valid for entry into the library premises by only **ONE** person at a time.
