

ADMISSION TO THE PHARMACY UNDERGRADUATE PROGRAMME AY2022-2023

HEALTH REQUIREMENTS

Besides the conditions indicated in the offer letter, admission to Pharmacy is also subject to the following health requirements. These additional requirements are mandated by the Ministry of Health (MOH) and apply to all healthcare workers, inclusive of pharmacy students. Students <u>must bring their vaccination records</u> for their pre-admission medical screening at University Health Centre (UHC). The absence of which will necessitate additional appointments and delay the process.

All candidates who do not have immunity may have their required immunisations done at the UHC Level 1, 20 Lower Kent Ridge Road, Singapore 119080. The deadlines by which the screening and immunisation must be completed are set out in the table below.

In light of COVID-19, please note that appointments for pre-admission medical screenings will be delayed. Please check UHC's website (http://www.nus.edu.sg/uhc) for regular updates, and plan accordingly.
