

Even though 2019 has drawn to its close, this stretch of organisational excellence journey is just beginning. Together with our partners, we will scale greater heights.


Our Strategy Map





NUS SAFETY, HEALTH AND EMERGENCY MANAGEMENT

OSHE provides a wide range of safety, health and emergency-related services to the NUS community and engages staff/students at every level to facilitate a safe and disaster-resilient university.






Safety and Health Management Division is responsible for facilitating the building of a safety, health positive and environmental culture and learning experience for all NUS staff and students through the adoption of safety & health best practices and systems.

Emergency Management Division

equips NUS staff and students with the knowledge and tools so that they can efficiently and effectively plan and organise their activities and events safely, and manage crisis and emergency situations expediently when they happen.

OSHE Alerts and Safety & Health Circulars

OSHE releases circulars and announcements to NUS staff and students pertaining to lessons learnt from accident and incidents, changes in regulations, reminders on good safety and health practices and launch of new programmes/ guidelines/ online modules. In 2019, seven circulars and two safety & health advisory/ announcements were released.





Audit Programme

The Audit Programme is an integral aspect of the PLAN-DO-CHECK-ACT system of management. This is to ensure that the Safety and Health Management System (SHMS) established by Departments and Academic Supervisors continues to be effective in managing the safety & health risks arising from their work activities.

Highlights

Frequency of Surveillance SHMS Audit for Academic Supervisors

A roadmap was developed for the gradual reduction of academic supervisors' surveillance audits for departments and academics supervisors that have demonstrated consistent safety and health performance. This will be implemented in three phases, with the first phase starting from March 2020.

Biological Safety Programme

The Biological Safety Programme is established to protect the safety and health of the University staff, students and visitors from exposure to biological hazards arising from research and teaching activities. OSHE reviews project risk assessments and protocols that involve biological materials to ensure safe conduct of research and ensures legal compliance such as regulations by Ministry of Health (MOH), National Environment Agency (NEA) and National Parks Board / Animal & Veterinary Service (NParks/AVS). The biomedical team also serves as a secretariat to the NUS Institutional Biosafety Committee (IBC), the MOH BiosIS administrator for non-advanced generation HIV lentiviral vectors, the administrator for Risk Group 2 veterinary biologics under the institutional Licence to Possess Veterinary Biologics and the central administrator for submission of proposals to Genetic Modification Advisory Committee (GMAC). OSHE collaborates with NUS Industry Liaison Office for the review of Material Transfer Agreement (MTA) questionnaires to ensure compliance to regulatory requirements for the acquisition of biological materials by Principal Investigators. The team also conducts training on safe handling of non-human primate (NHP)-derived materials and biological spill response.

Highlights

Commitment to Global Polio Eradication Initiative (GPEI)

On 30 April 2019, IBC released the standard entitled "NUS Risk Mitigation Plan for Oral Poliovirus Vaccine/Sabin Type 2 Potentially Infectious Materials (PIMs)" to ensure that NUS laboratories handle poliovirus PIM materials in accordance with MOH's and World Health Organization (WHO)'s requirements.

Launch of EHS360 Institutional Approval Module

On 10 October 2019, the online IT module *EHS360 Institutional Approval* was launched. It consists of (1) Genetic Modification Advisory Committee (GMAC) application submodule and (2) Licence to Possess Veterinary Biologics (LPVB) submodule.



Several roadshows were conducted before launch to familiarise stakeholders to the new workflow.

Engagement with regulators

OSHE continually engages regulators to streamline processes. On 31 July 2019, OSHE met with Animal & Veterinary Service (AVS) to discuss the streamlining of current processes for NUS institutional Licence to Possess Veterinary Biologics for Risk Group 2 veterinary biologics.

Chemical Safety Programme

The Chemical Safety Programme is established to protect the safety and health of the University staff, students and visitors from exposure to chemical hazards. The programme also facilitates compliance with the regulatory requirements concerning the possession and use of chemicals. OSHE reviews project risk assessments on safe handling of chemicals and ensures that relevant licences/permits are obtained. The team also conducts industrial hygiene (IH) monitoring for the University.

Highlights Laboratory Materials Purchase Requisition System (LMPRS)

In 2019, OSHE partnered with other administrative units and departments to develop the Laboratory Materials Purchase Requisition System (LMPRS). LMPRS is an online system that departments will use for the purchase of regulated chemicals. LMPRS is integrated with Laboratory Materials Management System (LMMS), allowing a



seamless user experience from chemical purchase requisition to inventory management. More than 50,000 chemical products were included into LMMS/LMPRS. LMMS and LMPRS facilitates by ensuring that Principal Investigators have the relevant licences to purchase chemicals and that the amount of regulated chemicals in the laboratories do not exceed the approved limits stipulated in the licence.

Construction Safety Programme

The construction safety programme is established for the management of NUS departments or offices supervising building and construction activities. OSHE provides advice to project managers on the design of buildings and facilities to ensure safety and health considerations are taken into account during the planning stage. OSHE also participates in construction and term contract tender evaluation for the selection of contractors for construction projects.

Quarterly meeting with Campus Operations and Maintenance offices

OSHE provides administrative support for the quarterly meeting with Office of Facilities Management (OFM) and Office of Estate Development (OED), where construction safety and related matters are discussed. Besides reviewing construction safety statistics and incident investigation reports, these meetings also served as a platform for discussion and decision on issues relevant to construction safety, such as traffic management in areas close to construction projects as well as review and update of construction safety specifications and requirements. Since 2018, 59 issues have been raised, discussed or decided in these meetings.



Radiation Safety Programme

The Radiation Safety Programme was established to protect the safety and health of the University staff, students and visitors from exposure to ionising and non-ionising radiation.

Highlights

Changes to non-ionising radiation licensing of confocal microscopes

Since 2008, NUS was in discussion with NEA for a re-evaluation of licence requirements for lab sonicators (N2 licence) and users of confocal microscopes (N3 licence). This discussion was a collaborative effort with NTU and A*STAR, with NEA at a workshop facilitated by the Pro-Enterprise Panel (PEP) under the Ministry of Trade and Industry (MTI) in 2018.

In Oct 2018, NEA agreed that the N3 user licence for use confocal microscope will not be required as long as certain conditions to ensure the safety of users are met.

Confocal microscopes that do not require N3 user licence

From 1 August 2019, N2 licences is no longer required for industrial ultrasound apparatus with power output less than 1,200 W. This was the result of the collaborative effort of a 10-year discussion with NEA.

As a result, OSHE managed to garner significant savings for the NUS researchers who use confocal microscope and/or own low-powered sonicators.

Field Research and Research Diving Safety Programme

The field research safety programme provides a framework for establishing policies and procedures that enable staff, students and other participants in NUS to undertake fieldwork safely.

Highlights

Adoption of Singapore Code of Practice for Scientific Diving

Since 1 June 2019, NUS adopted the Singapore Standard: Code of Practice for Scientific Diving SS623:2016. The standard specifies requirements for underwater research diving not exceeding 30 m, where breathing gas is supplied through self-contained underwater breathing apparatus (SCUBA).

Institutional Safety and Health Committees

The SHM division of OSHE provides administrative and secretariat support to several institutional-level committees, namely Safety & Health Management

Committee (SHMC), Institutional Biosafety Committee (IBC) and Institutional Laboratory Safety Committee (ILSC).

SHMC's primary role is to provide strategic direction on the development and implementation of a safety & health management framework that would safeguard NUS staff and students, the general public, and the environment from hazards arising from NUS activities.

The SHM division also reports to the Risk Management Steering Committee (RMSC) on the overall safety & health risk indicators on a quarterly basis on behalf of SHMC.

The IBC's primary role is to safeguard NUS staff and students, the general public, and the environment from biohazards and imposes requirements for safe practices involving biological materials. The IBC is chaired by Prof Barry Halliwell, with Dr Lim Cheh Peng as the Biosafety Coordinator and Dr Suzette De Leon as the IBC secretariat.

The ILSC's role is to provide strategic oversight on all laboratory-related safety & health issues excluding biological materials. ILSC was chaired by Prof Philip Liu and subsequently by Prof Ashraf Kassim. Mr Lionel Yap is the ILSC secretariat.

Emergency Preparedness and Crisis Management

OSHE strategises, implements and facilitates the crisis and emergency preparedness and management in NUS. The areas of responsibility include enabling the operational capability of the Crisis and Emergency Management Teams of the faculties and offices; business continuity management; preparedness and management of pandemic/epidemic; life safety of students and staff, university events and students' activities; safety and emergency preparedness for official overseas travels; fire safety management; and management of crisis and emergency.

Highlights International SOS

In 2019, Emergency Management Division provided consultation and facilitation to the NUS Office of Risk Management (ORM) in evaluating and engaging International SOS to be the service provider for our staff and student travel in safety and medical advisory of their intended areas of travel, and coordination for emergency medical evacuation.

Business Continuity Management

BCM is an integrated management process that identifies potential impact that threatens the University, faculties and units in fulfilling their key missions. It provides a framework for building resilience and the capability for an effective response that safeguards the interest of its key stakeholders, reputation, brand and value creating activities.

Emergency Management Division serves as the secretariat for NUS Business Continuity Management Committee (BCMC), facilitates and drives the BCM process by providing outreach, training, coaching, and consultation to the faculties, offices and units. We update the Risk Management Steering Committee on the overall state of readiness and ability of the University to ensure minimal business disruption when incidents occur. In 2019, OSHE conducted 88 consultation sessions with the various units.

Fire Safety

OSHE manages the Fire Safety Management Programme in the University. OSHE helps staff and students to attain a high standard of fire safety practices and maintains an effective rapid response force to respond to activation of fire alarms and fire incidents.

Highlights

<u>Transfer of Command and Management of the NUS Rapid Respond Team</u> (RRT) to OSHE from OCS

NUS RRT was established in 2015 under the Office of Campus Security (OCS) to provide quick response to fire incidents within NUS. The RRT was subsequently moved to OSHE Emergency Management Division in 2018. OSHE officially took over the command, control and management of the RRT on 01 April 2019.

LEAN AND GREEN

Green Laboratory Programme



The aim of the programme is to encourage NUS laboratories to reduce the environmental impact of their operations such as energy usage, water consumption and waste generation by

adopting best practices related to reducing consumption, recycling of materials, green procurement and inventory management. OSHE developed the GreenLab programme checklist for life science laboratories, chemical laboratories and equipment facilities.

Institutional Eye Protection Exemption Review Committee


Previously, the eye protection exemption was reviewed at either the Institutional Biosafety Committee (IBC) or the Institutional Laboratory Safety committee (ILSC) based on the type of materials that the laboratory was handling. To further streamline the review process and ensure consistency of approval across the two committees, the Institutional Eye Protection Exemption Review Committee was formed. The first meeting was conducted on 16 July 2019, where 24 out of 28 exemption requests were approved in an expedited manner.

Optimisation of Laboratory Ventilation

OSHE, together with the NUS Energy Taskforce, partnered Department of Building (School of Design & Environment (SDE)) to conduct research on how different ventilation rates affect the dispersion of volatile contaminants in a laboratory using computational flow dynamics (CFD). Results of this study allow the university to determine the optimal air change rate for labs as well as the design of ventilation systems.

OSHE also assisted the laboratories in MD 6 to conduct Laboratory Ventilation Risk Assessments (LVRA) to determine if the air change rate in these laboratories can be reduced without compromising safety. Air change rates in these laboratories have since been optimised and savings of up to 40% in electricity consumption is expected.

OSHE Organisational Excellence

existing process from project initiation to completion and handover to stakeholders.

<u>Information Resource Centre</u> Project

The Information Resource Centre Committee was formed to develop a framework to ensure timely and complete depository of information and the subsequent streamlined process for retrieval of information. Mr Joel Swee was a team member of the committee.

<u>Tender Award and Digital</u> Technology Roadmap Projects

Ms Gisela Ho was a Resource Panel member for two iETU projects — Tender Award and Digital Technology Roadmap. She provided suggestions to Initiative Owners on possible opportunities to streamline, centralise, automate, or outsource UCI processes.
